PROHIBITORY ORDER
(U/S 163 BNSS)

Whereas, I have reasons to believe that in view of strengthening Border Security and to resolve the issues faced by BSF personnel due to movement of persons after 6:00 PM along the Indo-Bangladesh Border, which has been a cause of hindrance while keeping an eye on activities across / within the Indo-Bangladesh Border and to prevent trans-border smuggling activities, under the jurisdiction of South Salmara Mankachar district.

AND

Whereas, I am satisfied that there are sufficient grounds for proceeding under section 163 BNSS, 2023 for immediate prohibition on movement of persons between 6:00 PM and 6:00 AM in the Indo-Bangladesh Border for ensuring uninterrupted watch on activities of the Indo-Bangladesh Border and to prevent trans-border smuggling activities.

AND

I, Shri Rahul Kumar Gupta, IAS, District Magistrate, South Salmara Mankachar, therefore, in exercise of the power conferred upon me under section 163 BNSS do hereby prohibit on movement of person(s) between 6:00 PM and 6:00 AM within 1000 (thousand) meters from Zero point of International Border on the Indian territory.

As the circumstances do not permit service of notice in due time, this order has been passed ex-parte under section 163 BNSS and will remain in force until further order.

Any violation of this order is punishable under the relevant provision of law.
