PROHIBITORY ORDER U/S 163 BNSS

Whereas, in view of the HSLC and HSSLC examination 2025 to be held in various centres in South Salmara Mankachar.

And

Whereas, it appears that, there is likelihood of large scale gathering of guardian & well-wishers of the candidates in and around the examination centre.

And

Whereas, it appears that, as a result of this large scale gathering, situation may arise, which may cause disturbance to the examiners and examinees which may hamper the smooth conduct of examination.

And

Whereas, for enabling the conduct of free and fair examination and to avoid any untoward incidents and also ensuring a conducive environment for the examiners and examinees, unabated movement of public, gathering of guardian and well-wishers within the periphery of 100 meters of the examination centres.

I, Shri Rahul Kumar Gupta, IAS, District Magistrate, South Salmara Mankachar therefore, in exercise of the power conferred upon me under section 163 BNSS do hereby prohibit the following throughout all the examination centres of South Salmara Mankachar district:

- 1) No person will be allowed within the radius of 100 mtrs of examination centres except students appearing for the examination and authorized personnel.
- 2) No parking and plying of vehicles will be allowed within the radius of the 100 mtrs from the examination centre except that of authorized person on duty during the examination.
- 3) Mobile Phones, calculators and any device which can be used for communication shall not be allowed inside the examination centre except that of centre in charge and authorized person on duty.
- 4) No food stall, shops etc. will be allowed within the radius of 100 mtrs of the examination centre.
- 5) Use of loudspeakers or any sound system will not be allowed in and around the examination centre till the completion of the examinations.
- 6) No other person will be allowed to guide the candidate for sitting on their allocated seats except the authorized / supervisory staff of the examination centre.

Due to urgent nature and necessity of the situation, this order is passed ex-parte U/S 163 BNSS. Any aggrieved person by the order may approach the competent authority.

This order shall come into force with immediate effect and until the examinations are over and violation of this order will be punishable U/S 223 of BNS.
