ORDER

Whereas, I have the reason to believe that it is necessary to impose restriction on use of loudspeakers / microphone/ other apparatus used for amplifying human voice or music etc. to ensure peaceful conduct of HSSLC (AHSEC) / HSLC/AHM Examination,2023. Further, the use of loudspeakers / microphone / other apparatus may create disturbances to students preparing for the HSSLC (AHSEC) / HSLC/AHM Examination etc.

Therefore, I, Shri Bidyut Bikash Bhagawati, ACS, District Magistrate of South Salmara Mankachar district, by the power conferred upon me under section 4(1) (a) of the Assam Loud Speakers (Control) Act, 1960, hereby restrict use of loudspeaker/ mics / microphones etc. in South Salmara Mankachar district to prevent annoyance to students/ disturbances to educational institutes during this Examination season.

Under this order, Officer-in-charges of all the Police Stations and Officer-in-charge of all the Out Post under South Salmara Mankachar are **Strictly directed** take necessary action to enforce and securing compliance with the order made under the act and seize any microphone, loud-speaker or any other apparatus used or operated in contravention of this order without prior permission from competent authority. Further, all other guidelines and restrictions as per Loud Speaker Act and Hon'ble Supreme Court Guidelines are also to be followed.

As the circumstances of situation does not admit service of notice in due time and in view of emergent nature of this order, it is being issued **ex-parte** and is addressed to the public in general.

This order shall come into force with immediate effect.
