ADVISORY NOTICE

In pursuance of the National Bulletin No. 14 (BOB/01/2024) issued by Indian Meteorological Department for severe cyclonic storm "Remal" which has developed over the North Bay of Bengal and moving northwards, it is expected to bring heavy winds and heavy rainfall over Assam and mostly southern parts of Assam including South Salmara Mankachar district w.e.f. 27th May to 28th May, 2024.

The following advisory has been issued in the interest of public safety and security:

1. Avoid going to areas that face water-logging and flash floods to prevent drowning.
2. During heavy rainfall, thunderstorm and lightning do not stay outdoors or move in open fields to prevent casualty due to lightning / thunderstorm.
3. Swimming activities in all rivers and other water bodies of the district are prohibited during this period.
4. Fishing activities in the all rivers in South Salmara Mankachar district are also prohibited during this period.
5. Farmers are advised to stay away from field level agricultural activities, cattle grazing activities during this period.
6. Be updated of weather forecast warnings.
7. If any power line or electric pole is seen to be damaged, do not touch and immediately inform APDCL, Mankachar.
