Following Functions should be included in the Block Level Child Marriage Prevention Committee (BLCMPC):-

1. The BLCMPC shall coordinate and prevent all Child Marriages and protection activities shall be carried out at Block level.
2. The Committee will support Block Level and Village Level Committee in regard to prevention of Child Marriages within respective Dev. Block.
3. The Committee will scheduled awareness programme to minimize Child Marriages within respective Dev. Block.
4. The Committee will identified left out Children and train them through Skill Development Department.
5. Network and Coordinate with all Government departments to build inter-sectoral linkages on child Marriages issues, including Department of Health Education, Social Welfare, Urban Basic Services, Backward Classes & Minorities, Youth Services, Police, Judiciary, Labour, State AIDS Control Society, among others,
6. Supervise and monitor all institutions/ agencies to make awareness against the Child Marriage and its consequences.

The Committee will sit at least once in every 3(three) months and as when need arises.


