ORDER

Perused the order received from the Executive Engineer, Inland Water Transport Division, Ulubari, Guwahati vide order No.- GC/146/Pt-XII/2023-24/5377-85 dated: 02/07/2024.

Whereas, it is observed that due to incessant rain in the past few days, the water level of Brahmaputra and its tributaries have risen alarmingly causing flood in several areas of the state. South Salmara Mankachar District is also likely to be affected adversely by flood.

In view of the prevailing flood situation and to prevent loss of human life and properties, and for greater interest of the public and on being satisfied with the reason for threatening disaster situation, I, Shri Rahul Kumar Gupta, IAS, District Commissioner, South Salmara Mankachar, in exercise of the powers conferred under Section 30 (2) (xviii) of Disaster Management Act., 2005 and being the Chairman of District Disaster Management Authority, South Salmara Mankachar, hereby order to suspend plying of all department & private boats, country boat, Launch in all ferry service under South Salmara Mankachar district temporarily with immediate effect barring essential services/ Relief & Rescue operation until further orders.

The Assistant Executive Engineer, IWT, Dhubri & i/c South Salmara Mankachar, will monitor the compliance of the order and inform the Chief Executive Officer, DDMA, South Salmara Mankachar on daily basis.
