ORDER

In consonance with the Integrated Child Protection guidelines and in order to promote child rights, it is hereby made mandatory that the Head of All Schools (Govt. & Private) shall report to their respective BEEOs and District Emergency Call Centre 1077 (DECC), in case of non-attendance of any student for more than 7 (seven) days without fail.

The Head of Schools shall start enquiring the whereabouts of the absentee student on the 5th day of absence in school by contacting parents, PRIs, members of the Village Level Child Protection Committee (VLCPC) or any other appropriate person in the locality with the help of staff as well as SMC/SMDC members and inform to the Block Development Education Officers and DECC on the 8th day of absence, if he has remained unsuccessful in obtaining any information.

It is also hereby made mandatory for all schools under South Salmara Mankachar district to display the information poster (copy of the poster to be collected from the CRCC) on the **Notice Board** and in **two** other prominent places within the school premises in a visible manner at all times. The last date for the compliance by the Head of Schools for display of information poster is 30th July, 2022.

The Head of schools shall inform all teachers and students in their respective schools regarding the contents of the information Poster.

This order shall come into force with immediate effect.
