Deep Depression over East Central Bay of Bengal (Cyclone alert for West Bengal Coast) Sub:

Sir,

With reference to the subject cited above, I would like to inform you that National Bulletin No. 8 (BOB/01/2024) issued by India Meteorological Department (Ministry of Earth Sciences) based on 1500 hours IST dtd. 25/05/2024 regarding Deep Depression over East Central Bay of Bengal nearly northwards and it is very likely to continue to move nearly northwards and intensify into a Cyclonic Storm over East Central & adjoining north Bay of Bengal and cross Bangladesh and adjoining West Bengal on 26th May, 2024 and accordingly, warning issued for squally wind speed reaching 40-50 kmph guesting to 60 kmph over South Assam on 27th May, 2024 with light to moderate rainfall at most places and very heavy rainfall at isolated places over Assam on 27th & 28th May, 2024.

In view of the above, the State Disaster Management Authority, Guwahati has issued directives to closely monitor the alarming situation and to issue restrictions on playing of boats in the River Brahmaputra and its tributaries on 27th & 28th May, 2024 in worst case scenario under appropriate sections of law if required.

You are hereby requested to monitor the alarming situation and inform all lessee of the ghats under IWT/Boat Owners Associations/IWT ghat officials to create awareness amongst people in affected areas to remain indoors during the warning period and to avoid staying in vulnerable structure.

You are also requested to keep close liaison with District Project Officer, DDMA/Field Officers of DDMA and inform the undersigned in case of any emergency.

The Circle Officers under South Salmara Mankachar District are requested to create awareness through their circle mechanism without creating panic amongst the general public and make publicity through miking, if required.
