5. Ensure setting up of District, Block and Village level Child Protection Committees for effecting implementation of programme as well as discharge of its functions.

6. Network and Coordinate with all Government departments to build inter-sectoral linkages on child Marriages issues, including Department of Health Education, Social Welfare, Urban Basic Services, Backward Classes & Minorities, Youth Services, Police, Judiciary, Labour, State AIDS Control Society, among others,
7. Supervise and monitor all institutions/ agencies to make awareness against the Child Marriage and its consequences.
