**ORDER**

Whereas, Section 126 of Representation of the People Act, 1951, specifies that in the period of 48 hours ending with the hour fixed for the close of poll, the election campaign will come to an end;

And whereas Election Commission of India has issued a notification vide No. 576/EXIT/2024/SDR/Vol.I, dated: 28/03/2024 banning the conduct, publication or publicising of exit polls between 7:00 AM on April 19, 2024 and 6:30 PM on June 1, 2024 in connection with Lok Sabha Election, 2024.

Now, therefore, to ensure peaceful, free and fair conduct of Lok Sabha Election, 2024 in South Salmara Mankachar district, I, Shri Rahul Kumar Gupta, IAS, District Commissioner & District Election Officer, South Salmara Mankachar, do hereby promulgate the following orders in the entire area of South Salmara Mankachar district:

1. Conducting and publishing or publicizing exit poll by means of the print or electronic media or dissemination in any other manner whatsoever, the result of any exit poll in connection with the current General Elections between 7:00 AM on 19th April, 2024 (Friday) and 6:30 PM on 1st June, 2024 (Saturday) shall be prohibited; Further
2. Displaying any election matter including results of any opinion poll or any other poll survey, in any electronic media, would be prohibited during the period of 48 hours ending with the hours fixed for the conclusion of the poll in connection with the aforesaid general elections.

This order comes into force with immediate effect.
