## **ORDER**

In pursuance of the District Weather warning alert on 25/05/2024 issued by India Meteorological Department, Ministry of Earth Sciences, Govt. of India and regarding the formation of Cyclonic Storm "Remal" (Pronounced as "Re- Mal") over East Central Bay of Bengal nearly northwards and it is very likely to continue to move nearly northwards and intensify into a Cyclonic Storm over East Central & adjoining north Bay of Bengal and cross Bangladesh and adjoining West Bengal on 26th May, 2024 and accordingly, warning issued for squally wind speed reaching 40-50 kmph guesting to 60 kmph over South Assam on 27th May, 2024 with light to moderate rainfall at most places and very heavy rainfall at isolated places over Assam on 27th & 28th May, 2024.

Whereas, due to cyclonic storm there may be high waves in the river Brahmaputra of the district which may cause Boat Capsize and also there is possibility of human causality.

Whereas, instruction received from Hon'ble Chief Secretary, Govt. of Assam to take precautionary measures including preventive measures like imposing restriction on playing of boats.

In view of the prevailing disaster situation and to prevent loss of human life and properties, and for greater interest of the public and on being satisfied with the reason for threatening disaster situation, I, Rahul Kumar Gupta, IAS, District Commissioner, South Salmara Mankachar, in exercise of the powers conferred under Section 30 (2) (xviii) of Disaster Management Act., 2005 being the Chairman of District Disaster Management Authority, South Salmara Mankachar, hereby order to suspend plying of all department of private boats, country boat, Lunch in all ferry service under South Salmara Mankachar district on 27th & 28th May, 2024.

The Asstt. Executive Engineer, IWT, Dhubri & i/c South Salmara Mankachar will monitor the compliance of the order and inform the CEO, DDMA, South Salmara Mankachar on above mentation days.
