**PROHIBITORY ORDER**  
**(U/S 163 BNSS)**

Whereas the Board Examinations (HSLC/HS) are approaching, it is imperative to ensure a conducive environment for students. Consequently, the use of loudspeakers/sound systems shall be prohibited until the completion of the Board Examinations. This is also in compliance with the Hon'ble Supreme Court's guidelines regarding the time schedule to not use any loudspeaker or sound system past **10:00 PM to 6:00 AM**.

And

Whereas the undersigned has observed that loudspeakers and loud sound systems are being used past 10:00 PM, and in some instances, without obtaining prior permission for the programs/event.

And

Whereas I am satisfied that there are sufficient grounds for proceeding under Section 163 BNSS, 2023 for the immediate prohibition on the use of loudspeakers/sound systems in South Salmara Mankachar district past 10:00 PM.

And

Therefore, I, **Shri Rahul Kumar Gupta, IAS, District Magistrate, South Salmara Mankachar**, in the exercise of the power conferred upon me under Section 163 BNSS, do hereby prohibit the use of loudspeakers/sound systems in South Salmara Mankachar district except for the use of loudspeakers or sound systems for emergency purposes.

As the circumstances do not permit the service of notice in due time, this order has been passed ex- parte under Section 163 BNSS and will remain in force until further orders. Any person aggrieved with this order is however at liberty to appear before the undersigned within 2(two) days from the date of issue of this order.

Any violation of this order is punishable under the relevant provisions of law, except for the use of loudspeakers or sound systems for emergency purposes.
