PROHIBITORY ORDER
(U/S 163 BNSS)

Whereas, the Assam Public Service Commission (APSC) is scheduled to conduct the Combined Competitive (Preliminary) Examination, 2025 on 5th July, 2026 (Sunday) at the designated examination centre namely, Hatsingimari College, Hatsingimari under South Salmara Mankachar district;

And whereas, directions have been received from the Secretary, Assam Public Service Commission, Khanapara, Guwahati, vide Letter No. 77PSC/E-11/2025-2026 dated 22/06/2026, to impose 163 BNSS within 100 meters of examination venue, as so to ensure the free, fair, smooth and transparent conduct of the examination and to maintain the security, discipline and confidentiality of the examination process. It has further been observed that any unauthorized gathering, entry, communication or interference in the vicinity of the examination centres is likely to disrupt the peaceful and orderly conduct of the examination.

And whereas, there exists sufficient ground for taking immediate preventive measures to prevent obstruction, disturbance of public tranquillity and any activity prejudicial to the peaceful and fair conduct of the examination;

Now, therefore, I, Shri Parikshit Thoudam, IAS, District Magistrate, South Salmara Mankachar, in exercise of powers conferred under Section 163 of the Bharatiya Nagarik Suraksha Sanhita, 2023, do hereby prohibit the following activities **on 5th July, 2026 within a radius of 100 (hundred) meters of Hatsingimari College, Hatsingimari:**

1. *Assembly or gathering not more than four (4) unauthorized persons.*
2. *Exhibition of any kind of advertisement by Coaching Institutes.*
3. *Unauthorized entry, photography, videography, communication or any activity intended to facilitate unfair means or disturb the examination process.*
4. *Use of loudspeakers, public address systems or any activity causing noise and disturbance w.e.f. 06:00pm of 04/07/2026 till completion of examination process on 05/07/2026.*
5. *Any act causing obstruction, interference or compromise to the security and orderly conduct of the examination.*

In view of the urgency of the situation, this order is passed ex parte. Any person aggrieved with this order is however at liberty to appear before the undersigned within two (2) days from the date of its issuance. Any violation of this order shall attract penal action under Section 223 of the Bharatiya Nyaya Sanhita, 2023 and other relevant provisions of law.

This order shall come into force with immediate effect and shall remain in force till completion of the APSC Combined Competitive (Preliminary) Examination process.


