**PROHIBITORY ORDER U/S 144 Cr.P.C.**

Whereas, the issue of prohibitory order under section 144 CrPC is felt necessary with a view to maintain peace, security and tranquillity of peaceful counting of votes in respect of General Election to Lok Sabha 2024 which will be held on 04/06/2024 and to prevent any untoward incidents in South Salmara Mankachar district during the counting of votes.

I, Shri Rahul Kumar Gupta, IAS, District Magistrate, South Salmara Mankachar therefore, in exercise of the power conferred upon me under section 144 Cr.P.C. do hereby promulgate prohibitory order banning the following in the interest of the maintaining peace and tranquillity in the South Salmara Mankachar District area during the counting of votes for the General Election 2024 of Mankachar LAC under 2 - Dhubri HPC:

1. Procession and sloganeering of any kind within the premises of the Counting Centre till completion of counting of votes and declaration of result.
2. Use of PA system/Loudspeaker and celebration of any political party or candidate within premises of the counting venue.
3. Carrying sticks with or without flags, lathis, firearms, gathering of 5 or more person within teh radius of 1 KM from the counting centre.
4. Bursting of firecrackers and fireworks, after the counting on 04/06/2024.
5. Carrying mobile phones, cameras, electronic gadgets inside the counting hall.
6. Victory procession / rallies by any candidate/political party without prior approval of the undersigned after declaration of results.

Considering the seriousness and urgency of the situation, this order has been passed ex-parte under section 144 CrPC and will remain in force until the completion of the counting of votes.

Any violation of this order is punishable Under Section 188 IPC under the relevant provision of law.
