

3	<ol style="list-style-type: none"> <li>In the 4<sup>th</sup> DRSC meeting, a resolution was passed for the development of the land for parking of buses in Hatsingimari town. Accordingly earth filling has already been completed in a part of proposed bus parking stand. But a another side of the bus stand, earth filling construction work had not been started.</li> <li>After completion of the construction work of proposed bus parking stand, a Stand Management Committee will be formed.</li> </ol>	<ol style="list-style-type: none"> <li>The Block Development Officer, Fekamari Development Block will take necessary action for completion of the construction work and submit present status report of the construction work within 30<sup>th</sup> September, 2022 without fail in coordination with DTO, South Salmara Mankachar.</li> <li>DTO, South Salmara Mankachar, President / Secretary, Bus Owner Association, South Salmara Mankachar will take necessary permission for formation of Stand Management Committee.</li> </ol>

Hence, presiding Chair directed the DTO, South Salmara Mankachar to hand over the DRSC file to the EE PWD (Roads), South Salmara Mankachar for smooth functioning of the upcoming DRSC meetings in the district.</p>
