In view of prevention of Child Marriage, a Village Level Child Marriage Prevention Committee should be formed in each village by the G.P Secretary of the respective G.P, which should includes at least the following members.

1. G.P President
2. G.P Secretary
3. Gaon Prodhan
4. Ward Members
5. ASHA Karmi of the village
6. AWA of the village
7. Teacher from the village
8. Any NGO

Following Functions should be included in the VillageLevel Child Marriage Prevention Committee (VLCMPC):-

1. The VLCMPC shall coordinate and prevent all Child Marriages and protection activities shall be carried out at Village level.
2. The Committee will support Block Level and Village Level Committee in regard to prevention of Child Marriages within the village.
3. The Committee will scheduled awareness programme to minimize Child Marriages within their village.
4. Network and Coordinate with all Government departments to build inter-sectoral linkages on child Marriages issues, including Department of Health Education, Social Welfare, Urban Basic Services, Backward Classes & Minorities, Youth Services, Police, Judiciary, Labour, State AIDS Control Society, among others,
5. Supervise and monitor all institutions/ agencies to make awareness against the Child Marriage and its consequences.

The Committee will sit at least once in every 2(two) months and as when need arises.
