Powers & function of District Level Committee:-

The District Level committee shall undertake all functions connected with implementation of this scheme at the District Level, and it shall also perform the following functions, namely:-

- 1. to evaluate the progress of implementation of this scheme in the concerned District and take corrective steps, wherever necessary;
- to submit a report on quarterly basis to the Standing Committee, including in electronic form and the report shall, inter alia, include month-wise statistics about the claim applications received, awarded. pending and reasons for pendency;
- 3. to keep close liaison with other authorities in the district so as to ensure that this scheme gets adequate publicity:
- 4. to provide guidance or clarifications to concerned authorities and claimants, wherever called for; and
- 5. to raise awareness about the rights available to claimants and the provision of compensation under this scheme.

This Committee shall come into force with immediate effect.
