Specification for Lifebuoy

- Material: High-density polyethylene (HDPE) or equivalent buoyant material.
- Diameter: Minimum 760 mm (30 inches) as per SOLAS (Safety of Life at Sea) regulations.
- Buoyancy: Minimum buoyancy of 14.5 kg (32 lbs) in freshwater.
- Weight: Lightweight yet durable, typically between 2.5 to 4 kg.
- Colour: International orange or bright red for high visibility.
- Reflective Tape: 360-degree reflective tape for visibility in low-light conditions.
- Grab Lines: Continuous grab line securely attached around the circumference, minimum 9.5 mm (3/8 inch) in diameter.
- Durability: UV-resistant, corrosion-resistant, and capable of withstanding harsh marine environments.
- Certification: Compliant with SOLAS, ISO 12402, or other relevant international standards.

Specification for Lifejacket

- Type: Specify the type (e.g., SOLAS-approved lifejacket, 150N, or 275N for offshore use).
- Buoyancy: Minimum buoyancy of 150N for adults (or 275N for offshore use).
- Material:Outer cover: Nylon or polyester (rip-resistant and water-repellent).Buoyancy material: Closed-cell foam or inflatable bladder.
- Closure System: Secure buckles, zippers, or straps for proper fit.
- Colour: Bright orange or yellow for high visibility.
- Reflective Strips: Reflective patches for visibility in low-light conditions.
- Whistle: Integrated whistle for signalling.
- Size Range: Designed for adults with a weight capacity of 40 kg (88 lbs) and above.
- Adjustability: Adjustable straps to ensure a snug fit for different body sizes.
- Certification: Compliant with SOLAS, ISO 12402-4, USCG, or EN 396 standards.
