PROHIBITORY ORDER U/S 163 BNSS

Whereas, Assam Public Service Commission, Jawaharnagar, Khanapara, Guwahati-22 has announced the schedule of the C.C. (Prelim) Examination, 2024.

Whereas, according to the schedule, the Combined Competitive (Prelim) Examination, 2024 will commence on 8th June, 2025 (Sunday) in two sessions, from 10:00 AM to 12:00 PM in the morning and 2:00 PM to 4:00 PM in the afternoon.

Whereas, in South Salmara Mankachar District, the said examination will be conducted in 1 (one) Venue Viz. Hatsingimari College, South Salmara Mankachar.

Whereas, it appears that, there is likelihood of large scale gathering of guardian & well-wishers of the candidates in and around the examination centre.

Whereas, it appears that, as a result of this large scale gathering, situation may arise, which may cause disturbance to the examiners and examinee which may hamper the smooth conduct of examination.

Whereas, for enabling the conduct of free and fair examination and also ensuring a conducive environment for the examiners and examinees, unabated movement of public, gathering of guardian and well-wishers within the periphery of the examination centre mentioned above be restricted.

I, Shri Rahul Kumar Gupta, IAS, District Magistrate, South Salmara Mankachar therefore, in exercise of the power conferred upon me under section 163 BNSS do hereby prohibit the assembling of more than 4(Four) persons within the periphery of 100 meters of the aforementioned examination centre in South Salmara Mankachar District from 8:00 AM to 4:00 PM on 8th June, 2025.

Due to urgent nature and as the circumstances do not admit of serving in the due time of notice upon the persons (public) against whom this order is directed, hence this order is passed ex-parte. Any person aggrieved with this order is however at liberty to appear before the undersigned within 2(two) days from the date of issue of this order.

This order shall come into force with immediate effect and until the examinations are over.
